## BOARD ACTION:

**Approval of Financial Investment Statements:** The Board approved the district's financial and investment statements for the month of June 2018.

**Personnel:** The Board employed the following individuals: **Joseph Collins**-Teacher/EHS and **Kathleen Renwand**-Special Education/Preschool Administrative Assistant/District.

**Resignation:** The Board accepted the resignation from the following individual: **Haley Baun**-Teacher/EHS.

**Accepted Gifts and/or Contributions:** The Board accepted the following donations/contributions: **Freudenberg-NOK**-donation of \$1000.00 to the Edison High School Science Lab Renovation Project; **Jayne Yost**-donation of \$39.00 to the Edison Benevolence Lunch fund and **Carey Stiles**-donation of \$18.85 to the Edison Benevolence Lunch fund.

**Approval of Interdistrict Open Enrollment:** The Board approved the interdistrict open enrollment option for the 2018-2019 school year provided by the Ohio Department of Education to permit any student from any school district in Ohio to apply for enrollment in the Edison Local School District free of any tuition obligation.

**Appointment of Nondiscrimination Officers:** The Board designated the following individuals to act as compliance/grievance officers for the 2018-2019 school year as required by state and federal law. The Board also designated respective building principals to carry out law enforcement responsibilities.

**Approval of Resolution to Institute a Reduction-In-Force/Budget Cuts:**
